HANDLING

SUITABLE: KEEP TIGHTLY CLOSED. KEEP AWAY FROM HEAT AND OPEN FLAME.

ENGINEERING CONTROLS

MECHANICAL EXHAUST REQUIRED. SAFETY SHOWER AND EYE BATH.

PERSONAL PROTECTIVE EQUIPMENT

RESPIRATORY: USE RESPIRATORS AND COMPONENTS TESTED AND APPROVED UNDER APPROPRIATE GOVERNMENT STANDARDS SUCH AS NIOSH (US) OR CEN (EU). WHERE RISK ASSESSMENT SHOWS AIR-PURIFYING RESPIRATORS ARE APPROPRIATE USE A FULL-FACE RESPIRATOR WITH MULTI-PURPOSE COMBINATION (US) OR TYPE ABEK (EN 14387) RESPIRATOR CARTRIDGES AS A BACKUP TO ENGINEERING CONTROLS.
